#### Proclamation - National 4-H Week

Missouri University Extension Council representative Amie Breshears was present as Commissioners signed a proclamation naming October 6th through October 12th, 2024, as National 4-H Week. Commissioners recognize the significant impact that 4-H has made on the youth of Benton County and expressed their continued support of this program.

#### Order/Ordinance to Authorize Property Tax Credit

Collector David Brodersen and Assessor Jim Hansen were present as Commissioners discussed the adoption of an ordinance to authorize a property tax credit pursuant to Senate Bill 190, Senate Bill 756, to provide property tax relief on senior citizens' primary residence. District 2 Commissioner Scott Harms made the motion to adopt the Ordinance to enact the property tax credit, District 1 Commissioner Larry Berry seconded the motion. The motion passed by vote: Larry Berry (Yes), Scott Harms (Yes), and Steve Daleske (Yes).

#### **Treasurer and County Clerk Reports**

The Treasurer presented his weekly financial report; the County Clerk submitted bills for approval and payment.

#### Sheriff

Sheriff Eric Knox met with Commissioners to discuss pay and benefits for his department, indicating that LAGERS is a necessity in order for him to maintain staff. Major Dean Noll was also present. Commissioners stated their concern about the buy-in process to implement LAGERS and indicated that the cost would be approximately \$850,000, plus an annual contribution fee. This cost information is based upon the study that Commissioners obtained from LAGERS that was completed in 2023, using information from fiscal year 2022.

#### LAGERS Review

Following Sheriff Knox's exit, Commissioners reviewed the LAGERS report that was compiled in 2023. This information detailed procedures and cost of enrolling Benton County employees in this retirement system and was received on May 31, 2023. This 49-page report identified the Unfunded Actuarial Accrued Liability (UAAL) for Benton County of approximately \$850,000; this amount is required to be paid to join the pension

plan.

Currently, County employees are enrolled in the County Employees' Retirement Fund (CERF) as mandated by the State of Missouri. The cost of this retirement program is funded by each employee's salary with no contribution by the County. Participation in CERF will still be required, even if Benton County enrolls in LAGERS. If Benton County joins the LAGERS program, it is estimated that the annual cost to the County would be approximately \$500,000 per year. This is in addition to the UAAL cost. After an extensive investigation, Commissioners determined that joining LAGERS would not be financially feasible.

#### **Fuel Bids**

District 1 Commissioner Larry Berry made the motion to approve the bid for diesel fuel for Road District #1 from MFA Oil Company at a cost of \$2.66 per gallon; District 2 Commissioner Scott Harms seconded the motion. The motion passed by vote: Larry Berry (Yes), Scott Harms (Yes), and Steve Daleske (Yes). Other bids were received from Warsaw Oil Company at a cost of \$2.86 per gallon, and from Zollicker Oil Company at a cost of \$2.82 per gallon; the County accepted the low bid price.

District 1 Commissioner Larry Berry made the motion to approve the bid for unleaded gasoline for Road District #1 from Warsaw Oil Company at a cost of \$2.55 per gallon; District 2 Commissioner Scott Harms seconded the motion. The motion passed by vote: Larry Berry (Yes), Scott Harms (Yes), and Steve Daleske (Yes). Other bids were received from MFA Oil Company at a cost of \$2.82 per gallon, and from Zollicker Oil Company at a cost of \$2.63 per gallon; the County accepted the low bid price.

### U.S. Army Corps of Engineers

A telephone conference call was conducted with U.S. Army Corps of Engineers representative Bradly Wright pertaining to a road in the southwest portion of the County.

#### **District Valuations**

County Clerk Susan Porterfield reported that she has received district valuations for 2024 from the assessor; valuations have been reported on Form 11A and submitted to the Missouri State Tax Commission. Districts will also be notified of these assessed valuations.
